- Scientists, researchers, innovators, and professionals with recognised achievements.
- Requires endorsement from a relevant UAE government body.

### 4. High-Demand Professionals

- Skilled professionals in medicine, engineering, technology, education, law, and critical industries.

### 5. Outstanding Students & Graduates

- High-achieving students from UAE universities or top global institutions.

### 6. Humanitarian Pioneers & Philanthropists
